TWC Member Meeting Minutes January 13, 2023

The meeting was called to order by President Bob Haarer at 7:05 pm.

Following a Pledge of Allegiance, Bob announced that he was collecting dues. He had no VP or Treasurer's reports. Bob Ashley asked those members to contact him in order to confirm the e-mail addresses that the club used to promulgate the newsletter.

St Lucie County Fair - starting Feb 24 through Mar 5. Bob will find out about passes to club attendees.

Bob Ashley reminded all that we are participating in the Stuart Water Fest on March 25th from 10:00am to 2:00PM—location is 300 SE Ocean Blvd & Georgia Avenue, Stuart, FL 34994

Fred commented that the club needs more participation in the production of work to be raffled off. He and a few others have been the major contributors. Bob agreed. There was a short discussion regarding a two-tiered raffle, with daily items raffled for \$1 and more distinctive items raffled for \$5. A motion was made to only raffle items for daily \$1 tickets and the motion was approved.

With February so busy, the club will hold it's general meeting at Jack's house on Weds Feb 8 at 4:00.

Bob announced that the club had not held an election since 2018 and was bound by the by-laws to hold annual elections. He complained that nobody had stepped forward to volunteer. Jack proposed a special meeting of the Board to prepare a slate of nominees to be held following the general meeting.


