

## TCWG General Meeting Minutes

April 11, 2024

#### Minutes for the General Membership Meeting 11 April 2024

Meeting started at 6:58 with a Pledge of Allegiance.

Recognition of visitors - Abe from Okeechobee who saw our website

Bob Ashley made a motion to accept the minutes of the January meeting as recorded in the March Newsletter. It was seconded and the motion was passed.

The Treasurer reported that the current balance of club funds is \$4,661. Anticipated expenses include rent payment for IRSC space and miscellaneous filing fees. The result will reduce the funds to approximately \$2,861. The club currently has approximately 40 members who have paid their dues.

Jimmy Porter, as the Safety Officer made a brief presentation regarding hearing protection. He noted that the cause for hearing loss included aging and exposure to loud noise. Because hearing loss is permanent, it is important to use protective devices including foam inserts for the ear or over the ear earmuffs. Both can be used together for maximum protection.

#### Old Business

Bob announced that the repair of two lathes was completed. He said that he has not had any productive discussions with IRSC regarding revision of club meeting dates. He indicated that progress has been made in transferring the title of the club equipment trailer but has yet to complete the title transfer. He also indicated that he is working on artwork for club business cards.

#### New Business

Bob announced his intent to order shirts for club members. He has quotes for collared shirts, similar to the ones previously ordered and also for T=shirts. After considerable discussion it was agreed that any member who wished to purchase a shirt would pay \$25 per shirt to the Treasurer who will notify Bob of the number, color and sizes of the order. Bob made a motion that only red club shirts would be worn for club events, although it would be acceptable for non-club shirts of any variety as well. The motion was seconded and passed.

Bob noted that a Board Meeting would be held after the General Meeting to discuss a club picnic and Beginner's Class.

#### Minutes for the General Membership Meeting 11 April 2024

Bob Haarer then held a wood auction for 20 minutes.

No demonstrations were presented.

Numerous members participated in the Show-N-Tell.

A motion to adjourn was made, seconded and passed at 8:30.

Attendance at this meeting was 28.

#### Minutes of the Board Meeting - 11 April 2024

Attendees: Board Members: Bob Ashley, Ron Augustyne, Steve Lasher, John Hart, Jack Shelton (ex officio), Bob Haarer, Ed Stavish and Conrad Stegner.

The Meeting of the Board was called to order at 8:40 by President Bob Ashley.

First item of business was a discussion of Club demonstrations. It was observed that the club calendar indicates multiple demonstrations or presentation subjects for the general meetings. None of the pas meetings have covered the entire range of subjects. Bob Ashley indicated that he felt it was necessary to have multiple subjects in order to cover the multitude of subjects. After discussion it was agreed that if only one subject were to be presented at each of the General Meeting and the Hands-On meeting, the club could cover up to 24 different subjects each year. Bob agreed to draft a list of subjects for demonstrations and discussion that assign a single item for each meeting. He will distribute the draft to board members for review and concurrence prior to the May meeting where it will be presented to the general membership.

The second item discussed was a grinder and associated equipment that Jack had purchased from a private party. He proposed that the club buy it from him at his cost - \$700 and sell the existing grinder and table at the May general meeting. The Board agreed to have this presented to the club members at the May meeting.

The third subject was an annual Club Picnic for members and families. It was agreed that this event be held on a Sunday afternoon in June at an outdoor venue with shelter. Bob Ashley will select a location and date. The club will provide beverages and chicken with the members encouraged to bring a potluck side dish or dessert to share. This will be presented to the general membership at the May meeting. A motion will be required to authorize the food purchase if it exceeds \$200. It was noted that in order to order the appropriate amount of food, members need to communicate the number of participants to Bob Ashley in advance. Bob will send an email to all members to ask for the headcount.

The fourth subject was a Beginner's Class. With 6 lathes, the class size will be limited 6 students. The classes will be held for 4 Saturdays starting in May. It was noted that members who wish to participate need to know the schedule as early as possible in order to plan ahead. Bob Ashley will coordinate with IRSC regarding the schedule and will email the schedule to the membership as soon as the schedule is fixed.

#### Minutes of the Board Meeting - 11 April 2024




A motion to adjourn was made, seconded and passed at 9:00
